What data we collect

We collect your Full Name and Email on our website Contact Us form. We are the sole owners of the information collected on this site. We only have access to the information you voluntarily give us. We will use your information to respond to you, regarding the reason you contacted us. We will not sell or rent this information to anyone (any third parties). We use your information to send you updates about us and our services but only once you have given us permission to do so.

What will we do with your information?

We will process the data you supply in order to provide any service you have requested when you sign-up on our website. We will only use your personal data for the purposes you have permitted, and we will not share it for marketing purposes outside of Jump PR Ltd. unless you have given us permission to do so.

We may use your data for the following:

To provide our services arising from any engagements entered between you and us, activities or online content and to deal with your requests and enquiries.

For "service administration purposes", which means that we may contact you for reasons related to the service, activity or online content you have signed up for.

To contact you about a submission you have made, including any content you provide.

To provide you with information about our services, activities or online content that you request from us and to provide you with information about other services we offer that are similar to those that you have already purchased or enquired about.

To provide you with information about our services we feel may interest you. If you are an existing client, we will only contact you by electronic means (e-mail) with information about services similar to those which were the subject of a previous instruction or engagement or negotiations of such to you. If you are not an existing client, and where we permit selected third parties (Mailchimp) to use your data, we will contact you by electronic means only if you have consented to this.

Note: We will only contact you with your consent.

Note: We do not rent, sell or exchange your information with any third party.

Where your data is held

Your data is held on secure servers operated by Jump PR Ltd in the UK. Our website has an SSL (Secure Sockets Layer) certification which provides world-class data protection and increases browsing confidence for our visitors and enables us to securely store confidential data using our website. We provide essential security and encryption to protect our login and administrative areas within our site and keep our customers and visitors data safe.

Data security

When you give your personal data to Jump PR Ltd we will process that data in accordance with our responsibilities under the Data Protection Act 1998, the GDPR 2018 and the Privacy and Electronic Communications (EC Directive) Regulations 2003 and the amended version of 2011 and other relevant legislation.
